### **Environmental Services Firm to Establish New Oil Recycling Facility in Speedway**

**INDIANAPOLIS** (July 12, 2010) – Heritage-Crystal Clean, Inc. (NASDAQ: HCCI) announced today that it has selected Indianapolis as the site for its used oil re-refining facility and intends to create up to 75 new jobs by 2013.

The company, which provides services for parts cleaning, containerized waste management, used oil collection and vacuum truck services to customers in the automotive service and manufacturing industries, expects to invest approximately \$40 million to construct and equip a new used oil re-refinery on West 10<sup>th</sup> Street in Speedway.

“Companies from across the country are realizing that Indiana is a smart place to establish and grow a business,” said Mitch Roob, Secretary of Commerce and Chief Executive Officer of the Indiana Economic Development Corporation. “We’re glad to see that Heritage-Crystal Clean has chosen to further invest in our state and create opportunities for Hoosiers in Central Indiana.”

Elgin, Illinois-based Heritage-Crystal Clean employs more than 500 employees and operates at 62 branch locations throughout the Midwest and the Eastern United States. The company expects to begin operating its new re-refinery at partial capacity in 2012 and is in the process of hiring oil route drivers, plant operators, maintenance and supervisory personnel.

“We chose Indiana because it is centrally located with good infrastructure and supports the recycling of used oil,” said Joe Chalhoub, CEO and President for Heritage-Crystal Clean.

Organized in Indiana in 1999, Heritage Crystal Clean, LLC has been expanding the parts cleaning and used oil recycling business started by its predecessor approximately 30 years ago.

“Indianapolis is where Heritage-Crystal Clean’s business began, and we couldn’t be more pleased that the company has chosen to build this re-refinery in the city where it all started and from where it quickly expanded its coverage area to serve its customers,” said Mayor Greg Ballard. “With its decision to build its used oil re-refining facility on the city’s Westside, Heritage-Crystal Clean recognizes that Indianapolis and the town of Speedway offer an ideal location and low costs of doing business. We welcome its growth and wish Heritage-Crystal Clean continued success.”

The Indiana Economic Development Corporation offered Heritage Crystal-Clean up to \$550,000 in performance-based tax credits based on the company’s job creation plans. Up to an additional \$100,000

will be made available to the city of Indianapolis for infrastructure improvements from the state's Industrial Development Grant Fund. The city of Indianapolis has granted Heritage Crystal-Clean a \$2.3 million property tax abatement and \$150,000 for additional infrastructure assistance at the request of Develop Indy.

"It's always great for the town when a business starts, grows and stays a part of the community. The jobs and the investment represent a commitment to the town of Speedway and demonstrate that this is a great place to do business," said Barbara Lawrence, town manager for Speedway.

Heritage-Crystal Clean's announcement comes just a little more than a week after Abound Solar Inc. announced that it will locate a solar module manufacturing operation in a Central Indiana facility previously constructed for German transmission maker, Getrag. Abound Solar projects to add up to 850 workers by 2013 at the Tipton, Ind. site.
